(7) AGREES TO SAVE, HOLD HARMLESS, DEFEND, AND INDEMNIFY THE CITY OF MONTE VISTA AND ITS OFFICERS, EMPLOYEES, AND AGENTS AS REQUIRED BY THE ORNINACES UNDER WHICH THIS PERMIT IS ISSUED;

(8) WARRANTS AND GUARANTEES COMPLETE PERFORMANCE OF ALL WORK UNDER THE PERMIT IN A MANNER ACCEPTABLE TO THE CITY OF MONTE VISTA, AND WARRANTS AND GUARANTEES ALL WORK DONE FOR A PERIOD OF THREE (3) YEARS AFTER PROBATIONARY ACCEPTANCE, AND AGREES TO MAINTAIN UPON DEMAND AND TO MAKE ALL NECESSARY REPAIRS DURING THE THREE (3) YEAR PERIOD, ALL AS REQUIRED BY THE ORDINANCES UNDER WHICH THIS PERMIT IS ISSUED;

(9) UNDERSTANDS AND AGREES THAT NO PERMIT WILL BE ISSUED UNTIL THE APPLICANT HAS FILED A BOND OR LETTER OF CREDIT IN THE FORM AND AMOUNT REQUIRED BY THE CITY OF MONTE VISTA; AND
